## **EMERGENCY RESPONSE GUIDE**

## **FIRE**

### R.A.C.E.

- Rescue persons in immediate danger to safety.
- Alarm Pull the nearest fire alarm box AND calling the emergency #.
- Contain by closing windows and doors
- Extinguish/Evacuate
  - Proceed to nearest exit using stairs, not elevators
  - Assist persons who cannot assist themselves
  - Meet at a designated assembly point
  - Re-enter only after being told to do so.



## WORKPLACE VIOLENCE

### **LOCKDOWN/ACTIVE THREATS**

- SECURE-Get inside and lock outside doors.
- LOCKDOWN-For threats or hazards actively engag-ing in the building
- ACTIVE ASSAILANT / SHOOTER-Call emergency #.
  - RUN-Out of the building or away from the area of attack.
  - HIDE-in a safe location with locking doors and limited windows.
  - **TAKE ACTION**-Disrupt or incapacitate the aggressor using force or physical items in view.



## MEDICAL GAS FAILURE

### **EVALUATE**

- Minor Leaks—Report to Facilities Department
- Major Leak/Failure—Contact Respiratory Therapy and Facilities Department
- Shut off medical gas only when:
  - Active fire involving patient or equipment utilizing medical gas
  - Fire spreading in a room with medical gas
- Charge Nurse, Nurse Manager, Respiratory, and Anesthesia have the authority to shut off medical gas



## SUSPICIOUS ACTIVITY

### **STAY CLEAR**

- Always report unusual or suspicious activity to hospital security.
- Open locked doors only for authorized and badged individuals
- Do not touch or disturb unknown/ suspicious objects
- Secure belongings, assets and research
- Re-enter the area only when directed to do so by authorities

## ADVERSE/SEVER WEATHER

## **SHELTER IN PLACE**

- Clear all items from window ledges.
- When possible, limit movement of personnel.
- Close all room doors to avoid flying objects.
- Close all fire doors to avoid flying debris.
- Move to the lowest interior area of building.
- Do not use elevators
- Make sure all secured areas remain secure.
- Monitor local media for action recommendations.

## TO UTILITY DISRUPTION

### **EVALUATE**

- Contact facilities and house supervisor
- Conduct an immediate assessment to determine extent of damage and potential need.
- Verify that applicable medical equipment is plugged into the red outlets if available.
- All life safety systems must be plugged into emergency outlets
- Evacuate building via stairs if necessary.



## HAZARDOUS MATERIAL RELEASE

### **EVACUATE**

- Contact facilities and house supervisor
- Alert people in immediate area to evacuate
- Avoid breathing vapors from spill
- If contaminated, seek eye wash and / or emergency shower
- Do not operate electrical devices or open flames within the spill area.
- Re-enter when directed.
